The main purpose of the Runtech activities at the Port Talbot installation are to serve the Tata Steel UK Limited

steelworks processes (permit number EPR/BL71081M). These activities are directly associated with steel production and include scarfing of steel slabs.

1. **Q4 2022 Monitoring Returns**

The operator submitted the Q4 2022 monitoring returns on the 28 January 2023, which is within the specified reporting window, representing compliance with the permit condition (4.2.3).

The permit requires the operator to monitor the following parameters on a quarterly basis:

Emission Point	Parameter	Emission Limit Value	Monitoring Frequency
AS 1	Particulate Matter	10 mg/m3	Continuous

Emissions monitoring demonstrates that the emission limit of 10 mg/m3 at AS 1 (Scarfig air filtration plant) was not exceeded during the reporting period.

Note: This CAR report and assessment was undertaken on 15 February 2023. However, to ensure that any non-compliance scores are attributed to the correct financial year (for billing) the date on the CARS system has been altered to 31 December 2021.
