4. Details of our assessment

The Annual Environmental Performance Report 2022 was received on 6th February 2023. Forms S1, Emissions to Sewer, 1st October - 31st December 2022, Water Usage1, Energy1 and Performance1 for 2022 were received on 31st January 2023. All the reports are accepted.

S1, Emissions to Sewer, 1st October - 31st December 2022

The total discharge was 2700m³ over 63 days which equals a daily discharge of 42,9m³. This is less than in the previous quarter.

WaterUsage1 2022

Total water use was about three times higher than in 2021 and increased by more than 45% per unit of production (puop).

EnergyUsage1 2022

Total energy use was almost four times higher than in 2021 and increased by more than 65% puop.

Performance1 2022

Production increased by more than 30%, compared with 2021.

Generation of residual waste was three times more than in 2021 and increased by more than 50% puop.

Waste water generated was more than in 2021 but decreased by about 15% puop.

Annual Environmental Performance Report 2022

There were four exceedances of the Welsh Water consent limit in 2022. One was for low pH, two for high ammonia, one for high zinc and one for high lead. The high ammonia was attributed to a fault with the aeration pump. Once this was rectified ammonia levels reduced. The high zinc and lead levels were thought to be because the tanks had been cleaned and insufficient time allowed for any residual sludge to settle. Procedures have since been changed.

Most of the average concentrations found by GD's internal analysis were slightly less than those reported in 2021, except for suspended solids.

The limits in GD's consent were tightened on 13th December 2022.

The actual volume discharged to sewer and the daily discharge rate were more than in 2021, mainly due to an increase in tanker work and commissioning of the wash plant.

GD's target to reduce energy use was not achieved. The biomass boiler was not operating in 2021, distorting the figures for 2022. Commissioning the wash plant also increased energy usage. GD plan to install solar panels by Q2 2023.

Emissions are monitored throughout the year.

There were no environmental accidents or incidents in 2022.

The increase in production is encouraging, but the associated increase in energy use and the proportion of residual waste generated puop is unfortunate. GD should be commended for the installation of solar panels and these should improve the energy situation.

Natural Resources Wales are pleased to see that the remedial measures put in place to ensure that the correct end of year reports are submitted have been effective.
