4. Details of our assessment

The Corporate ESH Target Overview for 2022 was received on 30th January 2023.
The report is accepted.

The reduction in energy use was set at 2%. The actual reduction was more than 20% or 10% per 1000 parts.

The target to reduce the amount of CO₂ generated from energy use was set at 2% and a reduction of 7% per 1000 parts was achieved.

The target of reducing water use per 1000 parts was 2% and the actual saving was 7%.

The waste generation reduction target was 2% per 1000 parts, the actual saving was 16%.

The target for increasing the amount of recycled waste was 2%, but this was not achieved due to the disposal of waste acid.

The target to reduce the amount of waste soluble oil from coolant was not achieved.

The focus of the EMS in 2022 was concentrated on energy use reduction and energy efficiency. Continental have been very successful in exceeding their targets for energy usage, water usage and total waste generation. However, recycling rates and coolant wastage did not meet the targets. This report demonstrates best practice in the effective use of an EMS review to improve the efficiency of resource use.
