4. Details of our assessment

At 10:44 on the 25th January 2023 a site inspection was undertaken by NRW officer Phil Harper. The inspection was undertaken in response to noise incident, which was received on the 24th January 2023.

Ammonia Plant

A visual inspection of the ammonia plant was undertaken. No visual issues were noted. A noise complaint was received on the 24th January 2023, with a schedule 5 notification from the operator stating that an air leak on the ammonia plant was responsible. Following the site meeting maintenance documentation has been received from the operator. The data will be reviewed and discussed in a separate compliance assessment report.

Effluent Treatment Plant

At the time of the visit works were underway to construct a foundation for a new balance tank. The effluent treatment plant was operational at the time of the inspection. No issues were noted.
