4. Details of our assessment

On the 16 December 2022, NRW officer Ffion Quan requested EDM data for Ynys Las Pumping Station for the period between 16/12/2021 and 16/12/2022 for a desktop OSM audit. On the 03 February 2023, Ffion Quan received the SPS spill data, South flow data, North flow data and the storm tank level for Ynys Las PS.

Having analysed the data received, it shows that Ynyslas Pumping Station spilled for a total of 1125 minutes over 4 separate occasions between 30/12/2021 and 05/01/2022. The permit for Ynyslas PS states that the works shall only discharge screened sewage in an

emergency.

An emergency is defined as:

- (i) an electrical or mechanical breakdown of such severity as to render the pumping station fully inoperable,
- (ii) total failure of external electrical supply,
- (iii) total blockage of rising mains.

The foregoing definition of 'emergency' shall not include station shutdown to enable routine maintenance.

ACTION - Please explain why Ynyslas Pumping Station spilled for a total of 1125 minutes over 4 separate occasions between 30/12/2021 and 05/01/2022 by no later than 08/03/2023.
