4. Details of our assessment

Attended site on the 16th Feb 2023

I was met by Mr Davies and he stated that he no longer dips his sheep, but has kept his permit, as a precaution.

We then made our way to the disposal area and i had no concerns with the area as nothing had changed and the field also was not drained. Mr Davies also stated that he used to graze sheep off farm and had a problem one year with Scab and had to inject them sheep, but kept them isolated until safe to merge with main flock. He has since changed his grass keep to a different area.

We then returned to the farm and as Mr Davies had not dipped sheep for over 6 years, I did not feel it a requirement to look at his dipping records, but would be utilised if dip was used in the future, the medicine store was in good order.
