4. Details of our assessment

Attended this site on the 3rd Feb 2023.

Was met on site by Mr Mills, his Son and daughter and was shown around the facilities, which were in excellent order and they stated that they do not keep sheep dip on farm as they buy it when they need it and calculations work out that they use the whole container during the dipping period.

Mr Mills then stated that he has contacted NRW about changing the disposal area due to a

new chicken shed being built on the site, but never had any response back from an officer. He then shown me the disposal site he had been using, which was a suitable location and it met the requirements with no impact of the environment. I stated that i would send over relevant details to change this condition within the permit.

We then looked at the records kept and they had been kept in excellent order and up to date.

We then discussed the new regulation and I looked over produced risk maps and they were also to an excellent standard.

I stated that i would send over information on The Water Resources (Control of Agricultural Pollution) (Wales) Regulations 2021 Guidance for Farmers and Land Managers, which was completed on the 04/02/23 via email.
