During a routine compliance assessment check we have carried out on 17/02/2023 it was noted that the Improvement Conditions information returns for EPR permit BP0110501 Felindre Farchog SPS had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.
