The Annual Report for 2018 and Forms WaterUsage1 and Energy1 for 2018 were received on 14<sup>th</sup> January 2019.

The reports are accepted.

### **Production**

Production volumes for oil increased by 37% compared with 2017.

29% less rags were accepted onto site, with the amount treated decreasing by 69% and 17% fewer sent for disposal, when compared with 2017.

### **Energy Usage, 2018**

Overall electricity use was 11% less than in 2017 and almost 40% less per tonne than in 2017.

Gas oil use increased significantly, by more than 75% compared with 2017, mainly due to a batch of oil that proved difficult to recover. Usage per tonne of product increased by 30% compared with 2017.

Primary energy use increased by 60% overall, mainly due to the increased use of gas oil explained above. However, it decreased by 17% once production volumes were taken into account.

### **Water Usage, 2018**

Overall water usage decreased slightly compared with 2017. The decrease per tonne of production was 29%.

### **Annual Report, 2018**

The annual improvement targets were achieved. Overall production volumes were higher than in 2017, allowing more efficient use of most resources.

There were no fugitive emissions from the site.

No mercury was discharged to sewer in 2018 as no waste of EWC 05 01 05, 06 or 12 was treated on site.

After an independent audit in July 2018 the site maintained its accreditations for ISO 9001, ISO 14001 and BS OHSAS 18001. They will expire in October 2021.

The weighbridge was out of calibration and has been replaced. Calibration certificates were received and have been filed by Natural Resources Wales.
