## 4. Details of our assessment

### **Review of Q4 2022 (October - December) monitoring returns and Schedule 5 notifications.**

Monitoring data was submitted to NRW on 30 January 2023 in accordance with Permit Condition 4.2.3.

#### ***Leachate***

Leachate levels were monitored monthly in accordance with Condition 3.5.1(a) and Table S3.1 (Leachate level limits and monitoring requirements). Transducer readings were provided for some monitoring wells.

During Q4 leachate heads between 0.49m and 32.60m were recorded against a compliance limit of 2m.

With reference to Schedule 5 notifications HAF322 (October), HAF323 (November) and HAF325 (December), there were 13 instances reported where the recorded leachate level was greater than 2m (excluding transducer readings). **NRW considers this a category 3 breach of Permit Condition 2.7.1 (B1 - Engineering for prevention and control of emissions).** The limit for the level of leachate listed in Schedule 3 - Table S3.1 (2m), shall not be exceeded.

**Action 1:** Operator to continue to ensure pumps and ancillary equipment are well maintained to maximise leachate removal.

It is noted that levels within Cell 5 are compliant.

A CCTV camera survey was undertaken in LC3, LC4 and LC5. A report has been submitted to NRW and this has provided useful information relating to the transducers and the level readings submitted by the Operator.

During Q4 4,121m<sup>3</sup> of leachate was tankered offsite for treatment.

Leachate sampling was completed in accordance with Condition 3.5.1(a) and Table S3.9 (Leachate – other monitoring requirements).

#### ***Landfill Gas***

Perimeter gas monitoring was undertaken in accordance with Condition 3.5.1(d) and Table

### 3.6 (Landfill gas in external boreholes).

With reference to Schedule 5 notifications HAF321 (October and November) and HAF324 (December), there were 26 instances during Q4 where methane levels in perimeter gas wells exceeded the 1% compliance limit. **NRW considers this a category 3 breach of Permit Condition 3.1.7 (E2 - Land and groundwater)**. The limits for landfill gas set out in Schedule 3 - Table S3.6 shall not be exceeded.

HAF321 (October) - elevated methane concentrations observed in boreholes GB04a, GB04b, GB06a, GB07a, GB09, GB10a and GB12, ranging between 1.3% (GBH10a) and 28.7% (GB04b).

HAF321 (November) - elevated methane concentrations observed in boreholes BH HA 10(B), BH HA 10(T), GB01, GB04a, GB06a, GB07a, GB08, GB09 and GB12, ranging between 1.2% (BH HA 10(B)) and 40.2% (GB06a).

HAF324 (December) - elevated methane concentrations observed in boreholes BH HA 10(B), BH HA 10(T), GB01, GB03, GB04a, GB06a, GB07a, GB08, GB09 and GB12, ranging between 1.3% (GB08) and 45.3% (GB06a).

**Action 2:** Operator to continue to follow landfill gas management plan and monitor closely.

Monthly in waste landfill gas monitoring was undertaken in accordance with Condition 3.5.1(d) and Table S3.8. Actual H<sub>2</sub>S levels were recorded across the gas field in November as the H<sub>2</sub>S filter was removed during the monitoring.

Weekly monitoring of the gas output to the LFG Utilisation Compound was undertaken in accordance with Condition 3.5.1(d) and Table S3.8

### **Groundwater**

Groundwater monitoring was undertaken in accordance with Condition 3.5.1(c) and Tables S3.5 (Groundwater – emission limits and monitoring requirements) and S3.11 (Groundwater – other monitoring requirements).

Monthly groundwater levels were obtained. Quarterly groundwater analysis was undertaken during November 2022. The samples were compliant with Condition 3.1.5, no breaches above the permitted ELVs were noted.

Samples were not taken from 7 locations (HA1A(T), HA5(T), HA9A(T), HA9B(M), HA10(T), HA11B(T) and HA12A(T)) as there was insufficient liquid to sample.

### **Surface Water**

Surface water monitoring was undertaken in accordance with Condition 3.5.1(b) and (e), and Tables S3.3 (Point source emissions to water - emission limits and monitoring requirements) and S3.10 (Surface water – other monitoring requirements).

All sample results were within the compliance limits specified in table S3.3. Quarterly monitoring was undertaken during October 2022.
