4. Details of our assessment

Bio-aerosol monitoring

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1. The permit requires bioaerosol monitoring to be undertaken twice a year.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- Aspergillus fumigatus - 500 cfu/m³
- Gram negative - 300 cfu/m³

Results from 12th August 2022 were received on 22 November 2022. Bio-aerosol concentrations were compliant at all sampling locations during this monitoring exercise.

Waste returns

Condition 4.2.2 requires that waste returns for the previous quarter shall be submitted within one month of the end of the quarter. Waste returns were submitted for all quarters.
