4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) regulating officer to comment upon the annual monitoring data and annual report for the regulated facility.

1. Annual Monitoring Data**1.1 Air Emissions - Emission Point A2**

Annual air monitoring was undertaken on the 20/10/2022 and submitted to NRW on 24/01/23 in accordance with Condition 4.2.3. Air emissions monitored for particulate matter (PM), lead (Pb) and volatile organic compounds (VOCs) were reviewed and all emissions were reported to be below permitted ELVs.

1.2 Emissions to Sewer - Monitoring Point S1

Annual sewer sampling and monitoring was undertaken on 14/06/22 and 09/12/22 and submitted to NRW on 24/01/23 in accordance with Condition 4.2.3. Sewer discharges analysed for Pb and chemical oxygen demand (COD) were reviewed and all emissions were reported to be below permitted ELVs.

2. Annual Report

Energy (E1) and waste data (R1) submitted for 2022 for permitted installation on 24/01/23 in accordance with Condition 4.2.3.

2.1 Energy Usage - E1

Electricity usage has reduced since the 2021 reporting period but carbon dioxide (CO2) emissions have more than doubled since 2021. The operator has stated that the reported CO2 emissions is due to an increase in the Kg CO2 (e) /kWh emissions factor, as informed by their climate change agreement partner.

2.2 Waste Data - R1

Reported waste data figures do not indicate any significant changes based on previous years data.

2.3 Environment Management System

During 30 August to 6 September 2022, a third-party audit body, RINA undertook a surveillance audit to ISO 14001:2015 Environmental Management System. No non-conformities were raised.
