4. Details of our assessment

Changes to the monitoring of the site were required from August 2022 following the BRef review and a revised permit being issued in June 2021.

Monitoring returns

Air emissions monitoring from A1 was undertaken in accordance with Condition 3.5.1(a).

Table S3.1 specifies the following limits:

- Odour - 1,000 ou_E/Nm³
- Dust - 5mg/Nm³
- TVOC - 40mg/Nm³

Results from 14 November 2022 were submitted to NRW on 31 January 2023. All results were compliant and below the ELVs stated in accordance with Condition 3.1.2.

Bio-aerosol monitoring was undertaken in accordance with Condition 3.5.1(c).

Table S3.4 specifies limits for bio-aerosol concentrations as:

- Total bacteria (TB) - 1000 cfu/m³
- Aspergillus fumigatus (AF) - 500 cfu/m³

Results from 18 October 2022 were received on 22 November 2022. Bio-aerosol concentrations were compliant at all sampling locations during this monitoring exercise in accordance with Condition 3.1.2.

There was no discharge to sewer during the reporting period.

The efficiency of the biofilter was monitored in accordance with Condition 3.5.1(b) and measured at 96.6%.

Annual performance reporting

Condition 4.2.2 of the permit requires a report on the performance of the permitted activities over the previous year to be submitted by 31 January.

The 2022 annual production / treatment data and performance parameters detailed in Schedule 4 Tables S4.2 and S4.3 were submitted on the 31 January 2023.

Waste returns

Condition 4.2.5 requires that quarterly waste returns for the previous quarter shall be

submitted within one month of the end of the reporting period. Waste returns were submitted for all quarters.
