4. Details of our assessment

On the 22nd August 2022, Morganite Electrical Carbon Limited Notified Natural Resources Wales (NRW) via email of an emission breach at the site during their monitoring. This CAR form has been produced following receipt of the operator's annual reporting to NRW.

The following text below outlines the notifications received from Morganite -

Emission point A27 (Total Particulate) - measured a value of 46.mg/m³ Permitted limit 10mg/m³

Emission point A28(Total Particulate) - measured a value of 18.14mg/m³ . Permitted limit 10mg/m³

Compliance - A non-compliance score of CCS3 has been attributed to both permit breaches.
