4. Details of our assessment

The site was visited on the 9th of February 2023 which was a dry and sunny day. It had been dry the previous few days too.

The site was visited as it discharges to the Afon Gwyrfa which is designated as a Special Area of Conservation (SAC) where the phosphate levels are of interest.

The outfall to the Afon Gwyrfa was inspected. It was seen that the headwall had collapsed.

It was understood that Dwr Cymru were planning on replacing the headwall. An useful discussion took place as to how to replace the headwall given that access for machinery is currently non-existent through the woodland between the sewage works and the river. Various biodiversity constraints also need to be considered in terms of the timing of work and surveys for protected species, as well as the presence of Japanese Knotweed.

Its understood that in high river flows effluent backs up within the final settlement tank within the sewage works. This means that the tank cannot function properly. A tide mark within the sampling chamber part of the settlement tank appeared to confirm this. The collapsed outfall headwall is understood to be part of the problem.

From NRWs perspective, the backing up of the effluent within the final settlement tank could result in an Operator Self Monitoring sample failing on solids. As such preventative action is needed.
