The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment against IQE (Europe) Limited (hereafter IQE) monitoring returns for both January to June and July to December 2022 and review the annual reports.

NRW received the following from IQE:

All parameters were well within all permitted limits through out the year for IQE.

Annual Reporting

Energy1

The sites primary energy usage has decreased from 2021. The site produced 194,047.54in² of wafers in 2022 with a CO₂ output of 0.0092g per inch² of wafer used.

Water 1

The site used 1,861m³ of water in 2022. This is down 23.7% from the previous year. This is a good trend with the site in reducing the volume of water used on site.

Waste Disposal & Recovery (R1)

Total amount of waste produced in 2022 was 194.45tonnes. Of this 184.5 tonnes was hazardous waste and 9.955tonnes was non-hazardous waste. Of the non-haz waste, 6098kg was sent to a waste to energy plant, 3169kg was recycled and 688kg was sent to landfill.

Again, this is a positive trend with the site by not producing as much waste from the last years.
