4. Details of our assessment

Celtic Chemicals

Celtic Chemicals Ltd (CCL) is a privately owned company who carry out chemical dissolution and packaging; powders blending and repackaging; and the storage and on-sale of chemicals. The company occupies several light industrial units within the Kenfig Industrial Estate.

Purpose of Compliance Assessment

The following monitoring returns and reports have been assessed within this Compliance Assessment Report (CAR):

1. Environment Agency Form L1 - 2022

The operator is required to submit a report on the performance of the activities over the previous year by 31 January. CCL submitted their annual report on the 13th February 2023; outside of the specified reporting window.

As a result of this reporting failure, a non-compliance score of C4 has been recorded against G4 – Reporting and notification to Natural Resources Wales.

Following assessment of the annual report, the subsequent observations were noted:

- Issues surrounding the commissioning of the wastewater treatment plant continue, with an alternative water treatment contractor required to review and complete the project.
- A significant volume of wastewater has been removed from Site following a site visit in May 2022.
 - Regular wastewater removal events are now required to prevent large volumes of wastewater from accumulating onsite.
- Plans are in place to extend the site in 2023 to include Unit 20, Kenfig Industrial Estate.
 - A permit variation will likely be required dependent on the intended use of the new industrial unit.
 - See advice and guidance provided with CAR_NRW0039872.
- Implementation of ISO14001 remains an improvement point. This has been a consideration since the permits issue in 2007.
 - NRW would welcome it's enactment.
- The annual submission contained all the required information in accordance with permit condition 4.2.1.
