4. Details of our assessment

Cenin Limited

The purpose of this Compliance Assessment Report (CAR) is to record Natural Resources Wales' (hereafter NRW) assessment against Cenin Limited (hereafter Cenin) Air and Water monitoring returns and their annual reporting of 2022 to NRW.

Cenin submitted their annual reporting to NRW on the 20th of January 2023. Due to the changes from the Waste Treatment Bref Review, Cenin's emission limit values (ELVs) had changed part way through the year. This required a separate form to be submitted, which was submitted on time.

Air Emissions

Cenin are required to submit results from emission point A1 which is for the Particulate Matter parameter.

From 01/01/2022 to 16/08/2022 the results show that 4mg/m³ is the highest figure read throughout this period. From the 17/08/2022 to 31/12/2022 the highest value was 0.03695mg/m³. This is well within the permitted limit of 10mg/m³ and the new ELV of 5mg/m³. This is compliant with the permit.

Performance 1 Form

Cenin submitted the performance form which relates to Table S4.3 in their permit.

No hazardous waste was produced in 2022.

No blast furnace slag was produced in 2022.

Due to the Waste Treatment Bref further parameters were required as part of the Performance 1 form.

The site used 24,604 tonnes of raw materials in 2022.

There was no generation of any residues nor any wastewater.

Accepted and compliant.

Waste Returns

Waste return have been submitted and accepted.

Water Usage

There is no water meter on site to calculate the site waster usage. However, the site does not sue water and is only used for domestic use and in staff welfare facilities.

Energy Usage

The site utilises 100% renewable energy which is supplied by the parent company 'Cenin Renewables'. The site used 568.495Mwh and have a specific usage of 0.02Mwh/Tonnes of sellable products.
