During a routine compliance assessment check we have carried out on 17/02/2023 it was noted that the Improvement Conditions information returns for EPR permit BB3893NJ Plas-Y-Coed CSO, Glynneath had not been submitted by the required deadline. In accordance with permit condition

2.4.1 The operator shall complete the improvements specified in schedule 1 table S1.3 by the date specified in that table unless otherwise agreed in writing by Natural Resources Wales, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.

Actions – please carry out the actions specified above to comply with permit condition 2.4.1 – The operator shall complete the improvements specified in schedule 1 table S1.3 by the date specified in that table unless otherwise agreed in writing by Natural Resources Wales.
