3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

4. Details of our assessment

A routine final effluent sample was taken from Llandygwydd Sewage Treatment Works (STW) (BH0063801) on the 30 March 2022 which was found to contain 29mg/l Biochemical Oxygen Demand (BOD) and 36.5mg/l suspended solids. As noted on the permit for Llandygwydd STW, the discharge shall contain no more than 30mg/l suspended solids and 20 mg/l BOD. Due to this, you have been scored a category 3 breach, which could have a minor environmental effect. Please also note that the phosphorus level was also measured high (9.14mg/l) within the sample, although this is not included in the permit for Llandygwydd STW.

During a telephone conversation on the 07 December 2022 between NRW officer Bethan Lewis and STW Project Manager at Ceredigion County Council (CCC) Cari Barker, it was discussed that the recent exceedances are believed to be in relation to the suspected fly-tipping incident that took place in 2018. It was believed that oil was discharged into the sewer system by a third-party, causing the bacteria at the STW to die, which is a detrimental aspect of the biological treatment at the works. Although CCC carried out a clean up of the works, the sample exceedances still persist. In response to the above, CCC had contacted both the manufacturer and Dwr Cymru Welsh Water (DCWW), who both visited the works but have been unsuccessful in identifying the cause of the persisting sample exceedances.

This CAR form is to be read in conjunction with CAR_NRW0040964 where further information is included regarding previous exceedances at Llandygwydd STW and a site visit which was undertaken by NRW officers Bethan Lewis and Ffion Quan on the 19 December 2022. Ceredigion County Council (CCC) have been requested to confirm their next steps in rectifying the sample exceedances at Llandygwydd STW by no later than the 14 April 2023.
