4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) regulating officer to comment on the 2022 Annual Report.

The annual report was submitted on 12/02/2023. Condition 4.2.1 of the Permit requires reports to be submitted by the 31 of January. **This has been scored a C4 breach of Condition 4.2.1.**

Performance Indicators have been recorded for the period 01/01/2022 to 31/12/2022 and are as follows:

- Production Man Hours increased by 7.8% on 2021, to 90,158 hours.
- Electricity usage is 2,151,266 per KWH, this is significantly higher than 2021 even when accounting for an increase in production man hours.
- Gas usage is 87,621m³ this is approximately 5% lower than usage recorded in 2021.
- 439 tonnes of waste was produced, which equates to 0.0048 tonnes of waste per production man hour, this is a slight increase on 2021. The waste figure includes off-site disposal of approximately 251 tonnes of waste water by tanker.
- Water usage for 2022, is recorded as 1,362m³, (0.015m³ per production man hour).
- Cardboard and plastic wrapping both now captured into the specific waste stream bailer.
- There has been no contamination or decontamination of the site in the year.
