4. Details of our assessment

The Annual Report for Bryn Posteg landfill permit has been submitted and this document has sections that refer to the gas engine monitoring requirements of this permit.

Section 2.4.1 states *'Monitoring reports of the emissions tests from the flare and landfill gas engines will be supplied to NRW directly, as soon as they become available. This is scheduled for the 3rd March 2023.'*

The gas engines have monitoring requirements that are to be performed annually. The annual report suggests that the engines have not been monitored in 2022. Table S3.1 states the monitoring frequencies and parameters that are required. Schedule 4 also lists the reporting requirements required for this monitoring and for annual production and treatment parameters and performance parameters. The lack of monitoring and reporting of data constitutes a breach and a consolidated score has been applied.

Score: (G1) Monitoring of emissions & environment. Permit Conditions 3.3.1, 4.2.2, 4.2.3. CCS Score 3.

Action: Conduct the monitoring as required by Table S3.1 and submit all data as required by Schedule 4.
