pc 4.1.4 - No issues reported

S4,2/2.4 - Site satisfied the permit condition by providing a table of analysis against LF gas, oils, water, glycol and battery acid, use and improvements.

Pc 2.6.2 Waste minimisation - site provided an evaluation of wastes arising from site and any options for improvements.

Annual flare stack (Landfill permit) running hours were 732 against an available 8760 which is 8.36% of the time.

Accident Management plan - 2 year requirement - no issues reported.

Site averaged 2.0 kg/MWh of NO<sub>2</sub> during 2022 and 6.4kg/MWh for CO - up on previous years.

Site completed its reporting schedule to NRW for 2022
