Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

On the 03/01/2023 we were informed by DCWW that a discharge of sewage had taken place to Limeslade Bay on the 31/12/2022 from Limeslade Sewage Pumping Station.

DCWW attended site on the 31/12/2022 in response to a high level alarm and found both pumps to be airlocked. Once the pumps were relieved of the airlock the levels returned to normal and the discharge stopped. The discharge lasted for approximately 1 hour and has been categorised as a Low Level Incident.

Whilst a permit to discharge in an Emergency is in place at Limeslade SPS, the discharge that occurred on the 31/12/2022 is not covered by Condition 2 of the permit which states that the Discharge shall only occur when:

(a) the sewage pumping station is inoperative as a result of one or more of the following:

- i. electrical power failure not due to the act or default of the Consent Holder, its agents, representatives, officers, employees or servants;
- ii. mechanical breakdown of duty and standby pumps;
- iii. rising main failure;
- iv. blockage of the downstream sewer not due to the act or default of the Consent Holder, its agents, representatives, officers, employees or servants:

It is an Offence under Regulation 38 (1) (a) of the Environmental Permitting Regulations 2016 in contravention of Regulation 12 (1) (b) to cause or knowingly permit a water discharge activity without an environmental permit.
