### 4. Details of our assessment

SRCL Code Change

SRCL notified NRW on the 17/11/2022 that SRCL have recently carried out a review of their permits and have been in discussion with the Environment Agency over the EWC code 15 01 10, which is currently used for the collection and disposal of lead foils.

The Environment Agency has informed SRCL that 15 01 04, metallic packaging, is a more appropriate code for this waste stream and are issuing a sector note until this is formally reflected in the permits.

SRCL requests NRW permission to use of code 15 01 04, metallic packaging for the lead foils instead of 15 01 10, packaging containing residues of or contaminated by hazardous substances.

NRW can confirm the code change can be made.

However the 15 01 04 code is currently not in the permit issued on the 7th May 2021. The permit requires a variation to add in the 15 01 04. This CAR form allows SRCL to use the code until the permit is varied in the future.

The code change must be added to the permit at the next opportunity.

**Action**

When the permit is next reviewed or changed, ensure that the code is added to the permit.
