### 4. Details of our assessment

NRW Officers Gillian Coates and Liz Park visited G F Grigg Ltd unannounced to inspect

the activities taking place under Environmental Permit GB3632AS. Weather conditions at the time of the inspection were dry and visibility was good. Officers were accompanied by Graham Grigg the Operator.

Graham Grigg explained to Officers that the site was winding down operations because of ill health and a wish to develop the site for an alternative use. A planning application to develop a holiday lodge park had been submitted to the local authority and he was waiting for a decision.

At the point that you decide to cease waste activities please contact NRW to discuss the surrender of your permit.

### Site Condition

There were a few deposits of aggregate material in the permit area which supported your explanation of recent activity. This was confirmed by your 2022 Q4 waste return which showed that only 91 tonnes of material had been accepted on to the site.

**NON-CONFORMITIES IDENTIFIED****G4 - Reporting & Notifications - Permit condition 4.2.2 - CCS Cat 4**

Through our discussions it came to our attention that you have not been completing the Waste Removed section on your waste returns. Your permit requires that:

- 4.2.2 Within one month of the end of each quarter, the operator shall submit to the Environment Agency using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter.

Having checked your returns for 2022, the waste removed tab on the return spreadsheet showed zero waste removed for all four quarters, however you informed us verbally that waste had been taken to Bryn Posteg. Because you have not reported on these waste movements, and it is evident that waste has been taken off site since our previous inspection, you have been scored a Category 4 breach of your permit conditions.

**ACTION - We agreed that you would add all the missing waste removed details to your quarterly waste returns and that you would email them to me and to NRW waste returns with a note of explanation. Please send this information and all relevant quarterly attachments by 10 March 2023.**
