4. Details of our assessment

On 9th January 2023 Kennametal notified Natural Resources Wales (NRW) that the emission limit value (ELV) for ammonia (NH₃) emissions to air from emission point A1 had been exceeded on 23rd November 2022. The measured emission was 147.4 mg/m³ +/- 17.7 mg/m³; the ELV is 30mg/m³.

The ELV for NH₃ emissions from A1 was breached in April 2019 (CAR_NRW0035157), attributed to a blocked afterburner lance. Procedures were amended. A further breach in August 2021 was caused by a change in manufacturing methods. In this case, the lances were found to be working correctly.

After this most recent breach, the lances were checked and found to be working correctly but were replaced anyway. Procedures have been reviewed and amended, operators retrained and checks by supervisors increased. A clean lance will be fitted before each firing and they have been modified to ensure that they fit correctly above the chimney. Emissions were re-tested after the actions above had been completed and were found to be less than the ELV.

The monitoring was carried out on 23rd November but NRW did not receive the Schedule 6 Notification until 9th January, seven weeks after the test. Kennametal should ensure that they receive monitoring results in a timely manner so that they can investigate any breaches as soon as possible and inform NRW quickly.

NRW hope that these latest improvements in operating procedures and supervision will prevent further breaches of the ELV for NH₃ from this emission point. NRW may take a more serious view of any future breaches of this magnitude. The procedures will be audited in due course.
