3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) regulating officer to comment upon the Annual Report and Q4 Monitoring Returns.

The Q4 Returns and Annual Report were submitted on 06/02/2023 and 14/02/2023 respectively. The Permit requires the Q4 Returns and Annual Report to be submitted by the 31 of January. **This has been scored a C4 breach of Conditions 4.2.2 and 4.2.3**

1. Q4 Monitoring Returns (October to December 2022) - Emissions to Water

October 2022 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

November 2022 - Returns did not report any exceedances of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1.

December 2022 - Returns reported the following exceedance of the emission limits specified in Condition 3.1.2 and Table S3.2 for emission point W1:

- Ammonia recorded at 2.87mg/l against a limit of 0.5mg/l on 20 December 2022.

Schedule 5 Notification: Part A & B

Part A and B received on the 6 January 2023 advising that:

Spot sample of treated wastewater leaving the plant has exceeded ammonia limit on permit. Ammonia spike reported with external sample analysis. Internal daily data had been within permit limits. No prior or initial indication of a potential breach.

Measure to be taken or intended to be taken are limited to querying accuracy of the results with the laboratory.

NRW consider this to be a C3 non compliance (see Actions).

2. Air Emissions - Emission Points A1 - A4

Air emissions monitoring was undertaken on 27 July 2022 in accordance with Condition 4.2 Table S3.1

3. Annual Report

Energy (E1) and water use (WU1) was submitted for the permitted installation as required by Condition 4.2. The report also includes production volumes and waste volumes

generated during 2022.

4. Actions

1. As outlined in the CAR dated 24/11/2022 (reference NRW 0040739) a root-cause-analysis of the continued breaches must be undertaken and reported back to NRW. The report to NRW must include a robust and realistic programme, which includes planning and timescales for appropriate mitigation as appropriate.
2. Returns must be provided to NRW in accordance with the timescales required by the permit. The Operator must review the sampling, testing and reporting currently undertaken and where appropriate modify to ensure that reporting to NRW is undertaken within the required timescales.
