4. Details of our assessment

Audit on 5th April 2022 to investigate x2 WIRS 2200440 and 2202444 which both reported discoloured effluent leaving the permitted discharge point.

Issues with incident were discussed. Believed to be linked to the maintenance of Final Settlement Tank 4. When it was brought back into operation, the tank wasn't cleansed beforehand, allowing debris to be discharged.

The site is still within permitted thresholds, so this is only being issued as advice and guidance.

This could be resolved by pumping over to Cilfynydd when necessary. We discussed the limitations of doing this, as it was understood overpumping could only happen a certain number of times per year. Below are the conditions around the joint treatment, which doesn't limit the number of times the transfer over to Cilfynydd can happen:

For combined Cynon and Cilfynydd effluent operation condition:

8. The volume of the Discharge shall not exceed 97,662 cubic metres per day.
9. The rate of Discharge shall not exceed 1130 litres per second.
10. The Dry Weather Flow of the Discharge shall not exceed 41,038 cubic metres per day.

For the purpose of this condition Dry Weather Flow shall mean the average daily flow to the treatment works during five consecutive working days without rain (excluding a period which includes public holidays) following seven days during which the rainfall did not exceed 0.25 millimetres on any one day.
