During a routine compliance assessment check we have carried out on 22/02/2023 it was noted that the Improvement Conditions information returns for EPR permit AN0158201 Newport No33 Brynglas Rd CSO had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvements Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.

Actions - Please carry out the actions specified above to comply with the permit condition 2.4.1.
