During a routine compliance assessment check we have carried out on 21/02/2023 it was noted that the Improvement Conditions information returns for EPR Permit AD0009306 CSO at Abertillery Foundary Bridge nr car park had not been submitted by the required deadline. In accordance with permit conditions 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.

Actions - Please carry out the actions specified above to comply with permit conditions 2.4.1.
