4. Details of our assessment

We have reviewed the following documents - 2023 Drill of Gas Collection Wells Construction Quality Assurance Plan V1 (received by NRW 01/02/23) and 2023 Drill of Gas Collection Wells Construction Quality Assurance Plan V2 (received by NRW 22/02/23).

We have the following comments:

Section 1.2 and Appendix 1 detail that the proposal is for retro drilling 8 gas extraction wells.

Section 2.9 details that a bentonite seal is installed to the upper 3m of the well. A dry bentonite powder is to be installed for the first 200mm above the gravel to prevent premixed bentonite from blocking the gravel annulus. The remaining 2.8m of bentonite is installed as a premixed bentonite slurry.

Points for consideration:

1. The proposed well locations are shown on drawing Hafod – Proposed Gas Wells – Jan 2023. In order to maximise performance, consideration should be given to sealing/decommissioning any nearby redundant wells or other features as shown on the drawing (e.g. W097, W098)
2. As detailed in the CQAP, Enovert will provide the CQAI's cv. This should be as soon as practicable and prior to commencement of works.

The changes from the original submission (V1 received by NRW on 01/02/23) are:

- 1) Locations of new gas wells have now been pegged out by surveyor
- 2) Two of the wells have been converted to 250mm casings from the original 160mm to aid dewatering if required.

We are satisfied with the information provided and approve the 2023 Drill of Gas Collection Wells Construction Quality Assurance Plan V2.
