The Annual Performance Report for 2018 was received on 21st January 2019.

The report is accepted.

There are no limits in the EPR permit for substances emitted to sewer, but the concentrations found by GD's internal analysis were all lower than those reported in 2017. The pH had risen slightly to a more neutral value.

The actual volume discharged to sewer has almost doubled when compared with 2017 and the average daily discharge has more than doubled, despite the discharge being over fewer days than in 2017.

Water usage has increased slightly; energy usage has increased by more than 15%. However, given the apparent increase in volumes of waste treated, this may equate to an actual reduction in use of resources. G D should consider measuring their resource use against the amount of waste treated so that they can evaluate changes in resource use efficiency more realistically.
