The Site Protection and Monitoring Plan has consistently identified Zone 9 as an area for concern with regards to metal concentrations in groundwater. Recommendations in this report include an investigation into the bund integrity in Building 9A. A survey of the bunds in Armour 1 has been completed and Natural Resources Wales have received a copy of the results of the investigation.

All the bunds were found to be in good condition.
