The Waste Minimisation Report for 2018 was received on 31<sup>st</sup> May 2019.

The report is accepted.

Waste generation in 2018 increased compared with 2017. There were two consignments of hazardous waste in 2018, a situation which is likely to continue in 2019. It is therefore more realistic to compare the 2018 waste figures with those from 2016, the last year when two consignments of hazardous waste were sent for disposal.

Waste sent to landfill increased compared with 2017 but was the same as in 2016. Recycled waste was more than 2.5 times higher than in 2017 and nearly twice as much as in 2016.

The ratio of recycled waste to landfilled waste fell slightly compared with 2017 but was nearly double that in 2016.

Waste generated per employee was higher than in 2017, but less than in 2016. Waste sent to landfill was higher than in 2017 but much less than in 2016. The amount of recycled waste also increased significantly compared with both 2017 and 2016.

Slightly less CO<sub>2</sub> was produced per employee in 2017, but the overall amount of CO<sub>2</sub> produced was higher than in both 2017 and 2016. CO<sub>2</sub> production per employee shows a decreasing trend over the last three years.

Overall water use and water use per employee have been showing a decreasing trend over the past three years.

This report demonstrates Poeton's continuing commitment to improving the efficiency of their use of resources.
