4. Details of our assessment

Monitoring requirements and annual report (Area 1 Closed landfill)

In accordance with the Area 1 Closure Plan (*DW13-CP01 v2*) we reviewed the current reporting requirements, along with when annual report is due. We agreed that these can be amended slightly, as detailed below.

- Leachate level - 6 monthly
- Leachate quality - annually
- Landfill gas - 6 monthly
- Groundwater level - 6 monthly
- Groundwater quality - annually
- Surface water - quarterly

In accordance with the Closure Plan and permit condition 45.2, we also agreed to reduce the frequency of topographical surveys for the closed landfill to one every 4 years.

The annual report is to be provided by 30th September each year.

Separately, we discussed an outstanding capping / restoration query and provision of CQA report.

Waste Returns (HHW site and composting)

Quarterly waste returns received and reviewed.

D&R codes for wastes received at the Household waste site and Composting clarified.

Annual tonnage exceedance considered a non-compliance CCS4 in first instance (refer to permit condition and table 71.2)

In our previous meetings we discussed how a permit variation would be required to increase tonnage, and provided pre-application advice. *Please provide a variation application as soon as practicable* (we also discussed an application to consolidate the permit would be beneficial)

In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
