During a routine compliance assessment check we have carried out on 27/02/2023 it was noted that the Improvement Conditions information returns for EPR permit AD0009001-West Side Sewer CSO had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.
