4. Details of our assessment

This Compliance Assessment Report (CAR) has been produced in response to the submission of annual performance report(s) and quarterly reporting required by the following environmental permit conditions.

Condition 4.2.2 of the environmental permit states:

A report or reports on the performance of the activities over the previous year shall be submitted to Natural Resources Wales by 31 January (or other date agreed in writing by Natural Resources Wales) each year. The report(s) shall include as a minimum:

(a) a review of the results of the monitoring and assessment carried out in accordance with the permit including an interpretive review of that data;

Condition 4.2.3 of the environmental permit states:

Within 28 days of the end of the reporting period the operator shall, unless otherwise agreed in writing by Natural Resources Wales, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit, as follows:

(b) for the reporting periods specified in schedule 4 table S4.1 and using the forms specified in schedule 4 table S4.2; and

(c) giving the information from such results and assessments as may be required by the forms specified in those tables.

Reported emissions for the month of December for suspended solids at monitoring point TSP1 and copper at monitoring point TSP2 were outside of specified limits of Table S3.1 which represents non-compliance with the environmental permit.

An investigation was undertaken to determine the cause. No incidents that could be attributed to the elevated result were identified. Interceptor maintenance is being arranged.

As a result of these two non-compliances, two C3 CCS Scores have been recorded against compliance sub-criteria E3 Emissions – Surface water.

Action: Operator to continue to monitor emissions and report emission limit breaches in line with environmental permit. Operator to undertake routine maintenance in line with site's environmental management system, namely interceptor maintenance. Action deadline: On-going.
