the Improvement Conditions information returns for EPR permit CG0050301 Ammanda Terrace Borth y Gest had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.
