Air1, Emissions to Air 2022

All parameters were within their respective emission limit values (ELV).

WaterUsage1 2022

Water usage was less than in 2021 but increased per tonne of production (ptp).

Energy1 2022

Total energy, gas and NG burner fuel use all increased in 2022 and also increased ptp.

Production was less in 2022 than in 2021.

Annual Review 2022

NOx emissions are controlled and within the ELV.

Performance Trend October 2022

This demonstrates compliance.
