4. Details of our assessment

CQA Proposal – Installation of Gas Extraction Wells – Record of Acceptance

The permit (condition 2.6.5) requires the operator to submit construction proposals, prior to the construction of any landfill infrastructure. Construction should not commence until Natural Resources Wales (NRW) has confirmed that it is satisfied with the construction proposals.

The operator has submitted construction proposals for the installation of a series of Gas Extraction Wells. The construction proposals consist of the following documents/submissions:

- Geotechnology Report: Withyhedge Landfill Site 2023 Gas Extraction Wells CQA Plan. Report Number 2337r1v1d0223 – dated February 2023.

NRW can now confirm that it is satisfied with the above submissions subject to the following caveats:

- Ensure the proposed landfill gas wells are installed and connected to the site's landfill gas extraction system as a matter of urgency, to maximise gas collection and reduce malodorous emissions.
- Ensure your monitoring and landfill gas management plans are updated to reflect the changes to the gas extraction system.
- Our comments are limited to the 13 gas wells which are to be installed imminently (GW23/6 to 8, GW23/12 to 14, GW23/17 to 19, GW23/23 to 25).
- The CQA plan also includes proposals for a further 13 wells (GW23/1 to 5, GW23/9 to 11; GW23/20 to 22) to be installed later in the year. The operator will need to submit the gas well location and drilling details for these remaining wells in advance of any proposed works. You will also need NRW approval before commencing with the installation of these remaining wells.

Please note that the acceptance of these CQA proposals, by NRW, does not mean that the assumptions, design specifications or testing regimes will be suitable for any future development at the site.
