3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Unannounced site inspection undertaken by David Ellar of Natural Resources Wales, accompanied on site by Dafydd Jones of TRJ Limited. The site was quiet and not a great deal of waste was present. Dafydd Jones explained that they had stopped taking in skips and were focusing on waste they generate themselves.

The weather was fine and dry during the visit.

Technically competent Manager

Under conditions 1.1.1 (b) and conditions 1.1.4, the operator is required to manage and operate the activities of the permit 1.1.1 (b) using sufficient competent persons and resources and 1.1.4 The operator shall comply with the requirements of an approved competency scheme.

Previously it was noted that Steffan Davies was identified as being TCM and was awaiting WAMITAB. Steffan has now left TRJ and Dafydd Jones is the TCM. Please supply WAMITAB record of continued competence for Dafydd Jones.

Action – Please provide evidence that Dafydd Jones meets requirements of conditions 1.1.1 (b) and 1.1.4.

Waste acceptance and storage

Under condition 2.2.1 and Table 2.2 of the environmental permit, wastes having one of the following characteristics shall not be accepted: 1 – consisting of solely or mainly dusts, powders or loose fibres. 2 – wastes that are in a form that is either sludge or liquid. During the inspection it was noted several oil drums were stored on hardstanding, on inspection these were full of an unidentified liquid. Dafydd Jones explained that tests had been undertaken but they were awaiting results before removal off site could be arranged. These drums must be removed to the quarantine area and removed off site or disposed of in line with Permit and site EMS.

This issue was also highlighted during our last visit and detailed in CAR_NRW0038856.

No spills were identified during the inspection in the surrounding area .

This has been scored as a category 3 breach of permit condition 2.2.1.

Action – All non-permitted wastes on site must be removed to the quarantine area whilst awaiting test results and then removed to an appropriately licenced facility.
