4. Details of our assessment

I, Industry & Waste Regulation Officer Magda Leonowicz, Industry & Waste Regulation

Officer Amy Bailey and Waste Permitting Officer Owen Clee conducted a first site inspection at PHS Group Cardiff, Unit 14, Moy Road Industrial Estate, Taff's Well, Cardiff, CF15 7QR on 18/11/2022.

On arrival, we were met by the Regional Manager Raza Sardar, the Regional Manager Charlie George and the Depot Manager James Harrison. The purpose of the visit was to introduce myself as the site's compliance officer and familiarise with the site's processes and operations as well as provide the operator with the information and services NRW can offer throughout the life of the permit. The weather was fine, with no precipitation and low wind speed.

The officers were provided a walkover tour around the site. All waste were stored in Euro-waste bins within the building with impermeable surface and sealed drainage. No waste was stored outside of the building. The site was well managed.

The first inspection checklist was discussed during the visit and signed by the Depot Manager James Harrison. The checklist has been scanned and saved to our database for information. No breaches were recorded during the visit.
