During a routine compliance assessment check we have carried out on 02/03/23 it was noted that the Improvement Conditions information returns for EPR permit CG0359701 Merllyn Lane Bagillt had not been submitted by the required deadline. In accordance with permit condition [2.4.1 – check permit], the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.
