## 4. Details of our assessment

During a routine compliance assessment check we have carried out on 02/03/2023 it was noted that the Improvement Conditions information returns for EPR permit AB3596ZT Carmarthen - Sticle Path had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.

Actions – please carry out the actions specified above to comply with permit condition 2.4.1 – check permit.

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
