During a routine compliance assessment check we have carried out on 3/3/2023 it was noted that the Improvement Conditions information returns for EPR permit CM0168801 Bagillt Greenacre Drive - SSO had not been submitted by the required deadline.

In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.

Actions – please carry out the actions specified above to comply with permit condition 2.4.1.
