During a routine compliance assessment check we have carried out on 02/03/23 it was noted that the Improvement Conditions information returns for EPR permit CM0172101 Frongoch (Rear of Magistrates Court) CSO had not been submitted by the required deadline. In accordance with permit condition [2.4.1 – check permit], the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.
