4. Details of our assessment

This meeting was held to discuss the commissioning plan for the new thermal treatment process. Robert Poyer Craig Masters Richard Jones and Rhiannon Chapple were all present from NUK.

The Ecosteryl 125 Microwave plant is now on site. It is currently being installed. We discussed the next steps of the commissioning process and the importance of ensuring all aspects of Annex 1 of EPR 5.07 is complied with. The permit links directly to this. The validation report must cover everything that is outlined in Annex 1.

We discussed the appropriate measure for the selection of test organisms, the requirements of using a challenge load. We also talked about spore strip quantities and spore strip containment. We discussed Annex 3 Emissions monitoring and the need for point source and fugitive emission monitoring. It was outlined the need for specialist microbiologist input and an accredited independent laboratory for this work.

We pencilled in the next site visit for the 20th March to run through the draft commissioning plan.
