During a routine compliance assessment check we have carried out on 06/03/2023 it was noted that the Improvement Conditions information returns for EPR permit BW2302001 CSO .400 YDS D/S Cluence Dulai had not been submitted by the required deadline. In accordance with permit condition 2.4.1, the Improvement Conditions information for this site should have already been submitted. Therefore a non-compliance has occurred.
