During a routine compliance assessment check we have carried out on 06/03/2023 it was noted that the Improvement Conditions information returns for EPR permit BW4100401 -

Drumau Farm Birchgrove Rd P.S. CSO, was not submitted by the required deadline specified under Condition 2.4.1 of the permit. Therefore a non-compliance has occurred.

The information was submitted on the 16/02/2023 so no further action is necessary. In future, please ensure that information is submitted within the timescales prescribed in the permit.

It is an offence under Regulation 38 (2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
